

Virtual Progressive Agriculture Safety Day® 2020 Release and Consent Form

In light of COVID-19, we are offering a virtual learning platform for youth participants who had their physical Progressive Agriculture Safety Day® cancelled or postponed this year. A condensed version of the program and Safety Day experience will all be delivered throughout a 2-hour period virtually. We ask that you carefully read and agree to the details below to allow your child to participate.

1) **I give my permission for the child listed below to attend the Virtual Progressive Agriculture Safety Day® held via Zoom Meetings.** I understand the purpose of the Progressive Agriculture Safety Day® is to teach participants about staying safe on farms, ranches and at home with a variety of age-appropriate lessons. All precautions to deliver this information in the safest manner have been implemented. We may offer suggestions for hands-on activities to be completed under parent/guardian supervision at home (to ensure they are performed safely and using only the materials suggested). I release the coordinators, instructors, volunteers, sponsors, the Progressive Agriculture Foundation, and the Progressive Agriculture Safety Day® program from all claims, in the event of injury to my child, unless the injury is the result of gross negligence or willful misconduct on the part of these parties.

2) Physical photos will not be taken during this virtual event; however, the Safety Day Coordinator may encourage you to share a photo or video of your child showing engagement in a hands-on safety or health activity. **I give my permission to use any photos submitted in the media, social media, on websites, and in promotional materials.**

3) **I understand that both my child and I may be asked to complete a knowledge survey** (these surveys could take place both before and upon conclusion of the virtual Safety Day). These surveys will help evaluate the effectiveness of the program.

Upon completion of the Virtual Progressive Agriculture Safety Day® and submission of an evaluation, you will be contacted about the pick-up process for your child's t-shirt, take-home bag and certificate of completion. The Safety Day Coordinator will ensure this procedure is done safely and in accordance with health practices surrounding COVID-19.
